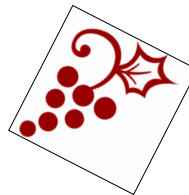

WHEREAS, the Cork in the Fork is a public event organized and coordinated by LFCA;
WHEREAS, LFCA and the Vendor wish to provide food for attendees at the Cork in the Fork, and agree that the food products offered to the public at the Cork in the Fork should be of the highest quality possible; NOW, THEREFORE, in consideration of the mutual promises contained herein, sufficiency of which is acknowledged, the parties agree as follows:

1. **Vendor Location:** The Cork in the Fork will take place in downtown Leipers Fork on November 5, 2011. LFCA agrees to provide Vendor with space at the Cork in the Fork at which Vendor will provide at least 3 pre-approved menu items as listed in Paragraph 6, attached hereto and made a part hereof. Vendor agrees that LFCA shall have sole authority and discretion in the assignment of the spaces at the Cork in the Fork. Vendor agrees to supply at least 2 employees, at own cost, serving dishes and table decoration.
2. **Amenities:** LFCA agrees to provide Vendor with the following amenities at Vendor's space location:
 - (a) Opportunity display your food products to hundreds of event attendees
 - (b) One (1) 10'x10' display space
 - (c) One (1) 6' skirted table
 - (d) Two (2) chairs
 - (e) Access to electrical outlets
 - (f) Two (2) entry passes to the Event
 - (g) Two (2) staff badges for Vendor booth
 - (h) One (1) booth sign with Vendor name
 - (i) Vendor listing on Event Program & on Event Website

3. The signed Agreement is due to LFCA no later than September 1, 2011

4. Hours of Operation: Vendor agrees to continuously operate during the official hours of the Event as: Saturday, November 05, 2011 7:00 PM to 9:00 PM. The Vendor shall be permitted to set-up its booth starting at 6:00 PM.

5. Vendor Menu: Vendor agrees to supply enough food for at least 400 guests. Vendor agrees to supply only those item (s) as listed below and approved by LFCA in advance of the Cork in the Fork. **Vendor explicitly agrees not to sell ANY FOOD or BEVERAGES at the Cork in the Fork.**

6. Vendor Obligation: Vendor also agrees:
(a) To clean Vendor’s space after event;
(b) To comply with arrangements made by LFCA for removal of waste and recycling from site;
(c) To comply with any other rules or regulations established by LFCA for Vendors and the Cork in the Fork.

7. Liability: Vendor agrees to pay for any damage done by it, its agents or employees to any personal or real property (e.g. tents, tables, structures, etc.) provided by or through LFCA to the Vendor at the Cork in the Fork.

8. Indemnification: Vendor agrees to indemnify LFCA, any officer, employee of LFCA, from any and all fees, costs and expenses incurred by them in connection with any claim, lawsuit, or proceedings arising out of or in connection with any act or omission of the Vendor or its agents in connection with the Vendor’s involvement with the Cork in the Fork.
